Adoption and Implementation

During Back to School Night each year, all parents are given the opportunity to volunteer to be a part of the Parent/Guardian Title Committee. All Title I teachers inform their students' parents that this committee will meet to review the Family Engagement Policy and adjust the policy as needed throughout the school year. Meetings

Meetings will occur on a continual basis throughout the school year. Meetings will be scheduled at various times to accommodate the schedules of all members. An annual meeting will be held within the first quarter of the school year. At this meeting:

These meetings will provide all parents of Title I students with an opportunity to plan, review, and offer suggestions to improve the Title I program, including the Parent and Family Engagement Policy.
